The Company may conduct the Contest concurrently and simultaneously on several participating radio stations owned and not owned by the Company, and in various States, and the Company may add or remove participating stations or change call letters of any participating station at any time during the Contest as announced on the affected station. Participating stations are listed above.

1. Description of Contest/Participation.

- A. Dates of Contest: The Contest will begin Friday, September 26, 2008 and end on or about Monday, December 1, 2008.

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of participants.

B. How to Enter:

Individuals 18 years or older and legal residents of Southern California must complete the following submission steps to be officially entered in the contest:

Every Friday, log on to www.southlandsoccer.com as part of KOST 103.5 and play the Southland Soccer Interactive Game and receive a score.

C. How to Play:

Every Friday starting at 9:00AM, the listener will be given the opportunity to play the Interactive Game on www.southlandsoccer.com for a score. On the following Monday at 9:00AM, the highest scorer from the weekend time period will be entered to win a Nintendo Wii. When the weekend high scorer is determined, entrant will be guided to fill out an online entry form. Once the online entry form is complete, the participant will be considered "entered" in the contest. Each week, a high scorer will be entered in the Contest.

By providing the entry elements described above, and officially entering this contest, individuals agree to: allow the Station to broadcast on-air and on-line all information provided for the purposes of promoting the contest, and accept and acknowledge the rules, regulations, restrictions and prize description "as is."

- D. Other Requirements: A maximum of one prize will be awarded at the end of the promotional flight.

The Prize winner will be selected randomly and notified on or around Monday, December 1, 2008.

2. Prize(s). One (1) eligible winner will be awarded a total of one (1) Nintendo Wii. Total Prize Value: \$ 299.99.

The prize elements will be awarded as described herein (subject to legal restrictions, etc).

The elements of the Prize are non-transferable, not redeemable for cash or exchangeable for any other prize.

If the winner is disqualified or is found to be ineligible for the contest, the Station reserves the right to determine an alternate winner or not to award the prize, at its sole discretion.

All prizes must be redeemed within 30 days of being notified by the promotions department that the prize is available for pick up unless otherwise specified at the time of winning. If a winner fails to pick up a dated prize in time to redeem the benefit, the winner forfeits the prize and no other prize will be awarded in its place. If a winner cannot be contacted or is disqualified, The Company reserves the right to determine an alternate winner or to not award that winner's prize, in its sole discretion. All prizes must be accepted as awarded. The Company retains the right to substitute a prize with another similar prize of equal or greater value in the event the original prize offered is not available due to circumstances beyond The Company's control. If prizes are to be mailed, they are to be sent to winners via standard United States Mail service, unless otherwise noted. Inability of winners to accept the prizes will result in forfeiture. Certain prizes may require winner to be 18 years of age or older, or have signed permission of parent or legal guardian to accept the prize.

3. Eligibility and Limitations. Participants and winner(s) must be U.S. residents at least 18-years old as determined by the Company and are legal residents of the Station's Total Survey Area (TSA). Participants must have and be able to present official state ID to contest officials before the prize will be awarded. Only one (1) entry per person per valid e-mail address and limit one (1) prize per household. Employees of the Company, Southland Soccer, the Contest's participating sponsors and their advertising agencies, employees of other radio or television stations, and members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

4. Telephone and Delivery Disclaimer. If a contest is a call in to win contest and/or a telephone is needed to participate in the Contest, participants are restricted to the use of ordinary telephone equipment. Participants that enable the "Caller ID" block function will not be allowed to participate unless they enter their correct area code and telephone number if prompted, or disable the features inhibiting their participation in the Contest. For all contests the Company disclaims all liability for any delays, mis-delivery, loss, or failure in the delivery of any item sent by mail, courier, express, electronic transmission, or other delivery method. 6. Release. By participating in the Contest, each participant and winner waives any and all claims of liability against the Company, Southland Soccer, its employees and agents, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize. In order to receive a prize, participants must sign an official waiver form provided by the Company.

7. Taxes. Any valuation of the prize(s) stated above is based on available information provided to the Company, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes related to the prize(s) and paying any expenses associated with any prize which are not specifically provided for in the official rules. All decisions will be made by the Company and are final. The Company may waive any of these rules in its sole discretion.
